#### **BOARD OF GOVERNORS**

As a result of a Special Meeting held in May at Indian Village Elementary School to hold Board elections, it was decided to form a nominating committee for election of members to the Board of Governors to be held at our October 9 Semi-Annual Meeting.

Goals of the nominating committee are:

To accept names of potential Board members until September 8, 2013.

To contact nominees/volunteers to see if they accept or decline nomination.

Ask nominees to submit a brief statement as to why they would be an asset to the Board.

At the election each PROPERTY will have one vote regardless if there are multiple owners. Indian Village residents who are renting may not nominate, serve on the Board, or vote. Five positions on the Board will be filled with the terms ranging from one to three years.

#### BOARD OF GOVERNOR RESPONSIBILITIES

Although positions on the Board are voluntary, there is a definite time and effort commitment involved and expected. The most important aspect of the "job" is always showing respect and consideration for every resident. We work for, and are responsible to, the residents who are also our neighbors.

Nominees should be aware that attendance is expected at all ten regular meetings and two semi-annual meetings. Participation in organization of our events is expected. This includes stuffing Easter eggs for the Easter Egg Hunt as well as getting there early to "police" the area (cleaning up debris and dog pooh that wasn't cleaned up by pet owners). Help is expected for organizing the 4<sup>th</sup> of July Bike Parade and Picnic as well as helping with judging the Christmas lighting contest.

Board members need to be available to answer or promptly return numerous phone calls and emails from residents covering a wide spectrum of issues. Some are easily answered or handled while others require researching City code issues and dealing with public officials as well as monitoring IVCA covenant violations.

In addition the Board has the responsibility of assuring that all financial accounts and dealings are handled timely and appropriately as well as producing Smoke Signals, correspondence to particular residents on specific issues when needed, arrangements for Semi-Annual Meetings (door prizes, obtaining speakers) and generally maintaining meeting minutes and other documentation of association business.

### COVENANTS

We still need residents to sign our pending covenant changes! ### MONUMENT AND TEEPEE REPAIRS

We realize both the monument and teepee repairs are of great concern, especially to our long time residents, and wanted to provide the following updates.

Within the next week, you should see activity begin on repairing the damage to our monument wall on Manito Boulevard. The original contractor chose to close his business earlier this year which made it necessary for us to find another contractor. We did find one who is familiar with Indian Village and is preparing to begin the repair work.

Concerning repairs to our teepees, we have a contractor who has worked on them in the past and we expect work to begin on the teepees within the next few weeks.

### TREES AND STUMPS

We have been attempting to obtain current specific information as to replacement not only for trees which have recently been removed, but trees which were removed within previous years. We have been advised that if a tree was removed that a resident previously paid the City to plant, we may be able to have it replaced at no charge. Also, we do have funds available in our Neighborhood Beautification Fund to help offset part of any tree replacement expense to individual owners that might be required by the City. Typically, the City plants trees in the fall to avoid drought situations that we experience during the summer. Regarding stump removal, we were advised early this year that the City was in the process of awarding stump removal contracts with the removal to begin this fall. So far, several stumps have been removed and we look forward to many more of the eyesores being removed.
