Holiday Lighting Contest

It's hard to believe that this week is Thanksgiving, which means the Holiday Lighting Contest is just around the corner. For those of you who are new to Indian Village, each year the Board goes around the Village and judges the decorated homes. The top 3 will have winner signs placed in their yards that will remain until the beginning of the year. The top five will also receiving monetary awards. The Grand Prize winner will receive a \$50 gift card and the 2nd through 5th place winners will each receive a \$25 gift card.

This year the judging for our annual Holiday Lighting Contest will take place from December 7 through December 10. Please have your holiday lights turned on those nights beginning at dusk so the Board can judge your home. If you do not wish to be judged, do not turn your lights on those nights. The final votes will be tallied at the Board of Governor's December Meeting on December 11. Prize winners will be notified the following weekend.

Last year 2338 Opechee Way won the Grand Prize, so that home is not eligible to be judged this year. The Grand Prize winner from 2011, 3702 Wawonaissa Trail, is eligible to be judged again this year.

Energizing Indiana

A year ago we began our partnership with Energizing Indiana. Since then, several homes have received their no cost energy audits along with receiving 9 CFL light bulbs, 2 high efficiency shower heads, and 3 sink aerators. The icing on the cake to this program is that for each home receiving an audit, Indian Village Community Association receives \$25!! That might not seem like much, but with 497 homes in the Village, if only 50% of them were audited, Indian Village would receive \$6,200!! There is no cost to homeowners to get the audit but you must use the form provided to Indian Village by Energizing Indiana for us to receive the \$25. Maintenance Fee Billing

The next Maintenance Fee billing will be mid December. Maintenance Fees are due the 1st of January. Residents have until the March Semiannual Meeting to pay their Maintenance Fees before the Late Fees are assessed. The Board feels it has identified most of the rentals in Indian Village. If you are a renter and you receive something mid December from IVCA, please forward it on to your landlord.

Do Unto Others ...

We are getting close to the time when snow falls and our streets become a challenge to navigate. When you are clearing your driveway, or even the street in front of your house, please be mindful of your neighbors and be careful not to pile your snow where it will be an inconvenience to others. The same can be said currently for the leaf situation. Even when walking your dog please remember to take bags with you so you can clean up after your pooch. The Year in Review

Early in 2013, Indian Village received CEDIT grant money from the City of Fort Wayne in the amount of \$4,075 to pay for our monument lighting project. The monuments look fantastic now at night!

In March we held our Semiannual Meeting where we heard from Ken Scheibenberger on drug houses and Amy-Jo Sites from Animal Care and Control on issues with raccoons and loose dogs and the consequences of such. 5th District City Councilman Geoff Paddock was also there to keep us up to date on what was going on downtown.

The Easter Egg Hunt, for the second year, was really cold! But that didn't stop the kids from coming out and hunting eggs, looking for that one "golden egg" that would lead them to a prize.

We held a logo design contest and challenged our residents to come up with their best design for a logo that Indian Village would use on correspondence, the Smoke Signals, and the website. Two residents were awarded cash prizes for their logos. One is being used on the Smoke Signals and correspondence, and the other is being used for Welcome Packets.

The annual 4th of July Bike Parade and Picnic was fun for everyone. The children loved decorating their bikes and being led by a fire truck and police car up to Psi Ote Park for the picnic. The Stand provided Coney dogs and there was Lee's Famous Recipe chicken too. It was a great time for neighbors to get out and socialize with others.

The October Semiannual Meeting was primarily for voting in a new IVCA Board of Governors. It was the first time, in a very long time that Indian Village held an election like this. The new Board is looking forward to exciting times in 2014!

Keep an Eye Out for ...

There have been quite a few incidents on the FWPD logs that refer to suspicious people, either on foot or in parked cars, within Indian Village recently.
