Sometimes people move, get sick or injured, or just plain find themselves with too much on their plates and then we lose Block Captains. Recently two of our Block Captain positions became available because of those aforementioned conditions. House Bill 1107

In December, Grant Shipley, IVCA's Attorney told the Board about a Bill that had been made into law that allowed neighborhoods with 12 or more sections, with different covenants for different sections, to become one section with one set of covenants. Grant wanted to ask Senator David Long if he would introduce legislation to change the number of sections from 12 to 5 so Indian Village would be included in the Bill, hence, House Bill 1107. The Bill has gone to the House for 3 readings and has passed in the House. Then we needed someone to sponsor the Bill in the Senate. Sen. Jim Banks (Columbia City) and Sen. Dennis Kruse (Auburn) have agreed to sponsor our Bill. It has had one reading in the Senate and that was on February 17. Grant went to Indianapolis to testify before the Senate about the need for this Bill for Indian Village. In an email from Grant after he testified this is what he wrote: "I testified today before the Senate committee considering the bill to allow Indian Village to consolidate its sections into one neighborhood. Also, Representative Dan Leonard was there to introduce the bill and speak on behalf of Indian Village. The Senate Committee recommended "do pass," after making one amendment. They liked our proposal so much they changed it from 5 sections down to 2 sections; any neighborhood with 2 or more sections should be allowed to use this procedure. From here it goes to the Senate floor for second reading and, if approved, then on to the Senate again for third and final reading. There's a vote and if it passes, the bill is sent back to the House (because of the amendment). Rep. Leonard says he will support the amendment in the House, so it will go straight to a final vote. If that passes, the bill is sent to the Governor for his signature. One step at a time. (I was told that Sen. David Long put in a good word for Indian Village as well.)"

Indian Village could actually be responsible for a new law! How COOL is that?!!

City Code ... How Well Do You Know It?

There have been two items that the Board has been hearing about from residents. The first is garbage cans left on the street for sometimes days at a time and the other is vehicles blocking sidewalks. We thought it would be good to include in this Smoke Signals just what the City of Fort Wayne Code has to say about these concerns.

§ 50.06 SET-OUT TIME FOR REFUSE CONTAINERS AND RECYCLING CONTAINERS.

(A) All residential garbage, curbside recycling and yard waste collections will be made between the hours of 5:00 a.m. and 11:00 p.m. on the designated collection day. Refuse containers, refuse bags, garbage can liners, bulky waste, recycling containers, and/or yard waste containers (excluding leaves placed at the curb as part of the city's fall leaf collection) shall be set out at the refuse collection site, curbside or alley, on the designated collection day before 5:00 a.m. and no earlier than noon of the day preceding the regular collection day. The refuse containers, refuse bags, garbage can liners, bulky waste, recycling containers, and/or yard waste containers (excluding leaves placed at the curb as part of the city's fall leaf collection) shall be removed from the refuse collection site no later than noon on the day after the regular collection. The owner, tenant, lessee occupant, or agent of any property shall promptly clean up and remove any scattered solid waste, rejected items, recyclable material and/or yard waste (excluding leaves placed at the curb as part of the city's fall leaf collection) from the property before noon on the day after the scheduled date of regular collection. Missed collections that are a result of the contractors' negligence will be an exception to having solid waste materials removed from the refuse collection site no later than noon the day after the regular collection day.

(B) It shall be unlawful and a violation of this section to knowingly dispose of motor oil antifreeze, car batteries, and other toxic materials in with garbage and/or recycling collection.

§ 99.020 OBSTRUCTING FREE PASSAGE UPON STREETS AND SIDEWALKS.

(A) It shall be unlawful for any person to obstruct the free passage along and upon any street, sidewalk, space between sidewalk and curbing, or commonly traveled portion of a street or other public place, and to place or permit to be placed upon such street, sidewalk, space between sidewalk and curbing, or commonly traveled portion of a street or any other public place, any thing or object whatsoever so as to obstruct or block the use thereof, or so to endanger the life or limb, or property of other using such passage.

(B) The city by and through its Board of Public Safety, may grant a permit to exempt any person or organization from the prohibitions set out in the preceding paragraph.

(C) The city by and through its Board of Public Safety, shall enact rules and regulations governing the use of it rights-of-way by those persons or organizations granted a permit pursuant to paragraph (B) of this section. The rules and regulations may include:

(1) The price of the permit.

(2) Limitation on the size, location and duration of any structure placed on the city's rights-of-way.

(3) A requirement that the permittee indemnify the city against any loss arising out of the use of the permit.

(4) Any other matter affecting the public health, safety and welfare.

(D) The rules and regulations enacted by the Board of Public Safety shall be subject to subsequent ratification by resolution of the Common Council.
